The Whanganui District Licensing Committee received an application from Shree Sai Holdings (New Plymouth) Limited to renew Off-Licence (36/OFF/003/2018.1).

The renewal application was made under s.127 of the Sale and Supply of Alcohol Act 2012 and accordingly publically notified.
