Please use this space to provide any further feedback or comments you wish to make:	I would like to suggest that Whanganus District Council allocate some extra Annual Plan budget for a locally-led awareness campaign for the new trial bus service starting in 2023. I believe that a small amount of funding could allow us to work with Horizons to source local producers in designing a service brand and signage, postering and billboard advertising, and video content designed for digital marketing. Additionally, the budget would allow for a specialist-led digital campaign on social media, and a concurrent physical advertising campaign using postering and digital billboards. The campaign could be informed by our recent public transport survey, which has found that awareness and understanding of the bus system is at low levels. I would suggest a budget of \$25,000 - \$35,000 for this work. The budget may be able to be matched through conversations with Horizons and Waka Kotahi. If it is not able to be matched, \$35,000 would be a productive budget for a locally led awareness campaign.
