I agree to accept this services under the following conditions:

1. That I will bear the complete cost of installation of the service connection, including the cost of the meter, all fittings required, and any length of pipe required to reach my boundary from the supply main, the whole of the work to be performed by the Whanganui District Council Infrastructure Group or its agents to the standards set by the Whanganui District Council Infrastructure Group.
2. They agree to pay the Minimum Allocation Charge for water on a six monthly basis or as the Whanganui District Council may determine. They also agree to pay within 20 (twenty) days of receipt of invoice for water recorded through the meter at the rate fixed by resolution of the Whanganui District Council from time to time.
3. That in the event of my failing to meet such charges under Clauses (1) and (2), the Whanganui District Council Infrastructure Group shall be empowered to immediately cut off the service without further notice.
4. That at any time a change of ownership or occupancy should take place in the premises served by the connection, I agree to advise the Whanganui District Council Infrastructure Group within fourteen days and meet all charges up to and inclusive of the date of cessation of occupancy or ownership by me, or in event of my failing to give such advice I will continue to remain liable for all charges incurred.
5. That in the event of work being carried out on the mains (whether or an emergency nature or programmed) or any other emergency, the Whanganui District Council Infrastructure Group cuts off the supply to my premises, it may do so without any liability devolving upon it for the interruption or discontinuance of the supply.

6. That in the event of the Whanganui District Council Infrastructure Group or its officers not being satisfied that the meter is in good working order or recording accurately, it shall be empowered to test the meter, and if found to be faulty to repair or replace the meter. During any period when the meter may be out for repair or ceased to register correctly, I agree to a charge being assessed on the basis of the average of the four previous similar periods registered through the meter.
7. If at any time the accuracy of the meter is called in question by me, I agree to the Whanganui District Council Infrastructure Group testing the meter, and if such meter is found to register within 5% over or under the absolute quantity passing through I agree to pay the cost of testing, removal and fixing.
8. I agree to abide by all conditions laid down in the Whanganui District Council Bylaws.
9. I agree to provide one day's (24 hours) storage on site.
