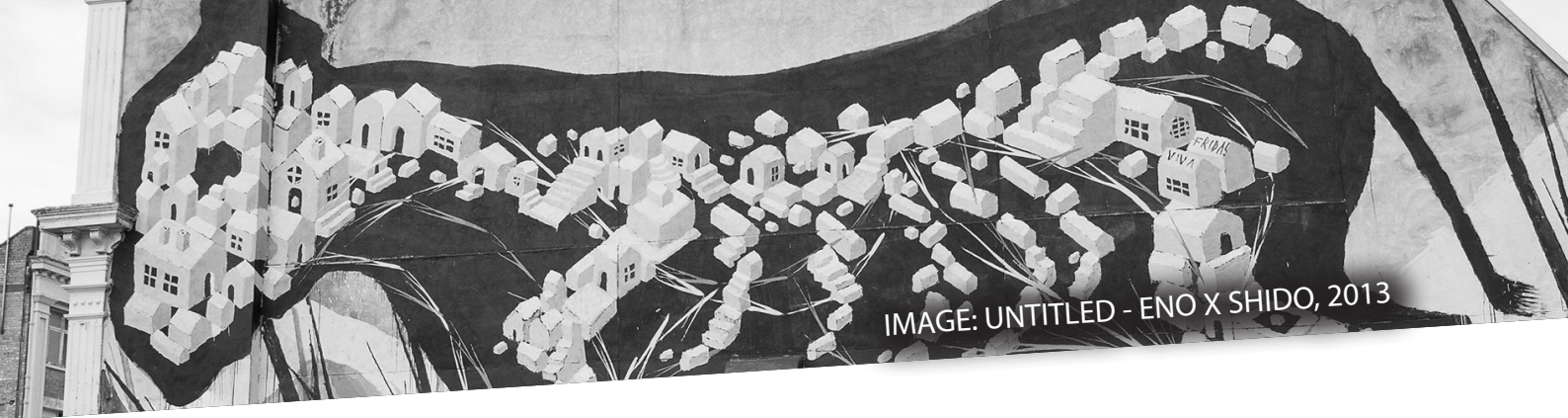


2023 PUBLIC ART FUND GUIDELINES

The Whanganui District Council administers the Public Art Fund to support the delivery of innovative and diverse public art across the region. The fund enables local artists to create artworks which showcase the distinctiveness of Whanganui's environment, history and cultural identity.

The Public Art Steering Group, which consists of representatives with relevant expertise and knowledge, assess all applications to ensure assessment criteria and the desired public art outcomes. The assessment criteria are outlined in these guidelines.

All proposals must be discussed with the [Creative Community Advisor](#) before submission.

Eligible projects could include (but are not limited to):

- ◆ Works such as sculpture, street-art, pou whenua, sound, light, new-genre public art, land art, murals, relational aesthetics, digital art, moving image and installations.
- ◆ Artists contributing to urban design developments (such as parks, streets, bridges, buildings and street furniture).
- ◆ Temporary public art activities and events, such as performance artworks, time-based sculpture, projections, paste-ups, media arts, and movable works.
- ◆ Artists working with communities in public spaces.

Funding:

The Public Art Fund is a contestable match funding scheme. This means applications must include additional funding close to or equal to the amount requested from the fund. For instance, if your project costs amount to \$10,000, you may apply for \$5000 from the Public Art Fund, and another \$5000 must be matched by another funder. Match funding may also include in-kind support.

This year there is a total of \$52,500 available for applicants.

In the case of larger projects, an application for funds for the same project may be made in consecutive years.

To be eligible for funding, artworks must:

- ◆ Be installed or performed in a public space in the Whanganui District
- ◆ Consider public safety
- ◆ Work with the Creative Community Advisor to develop maintenance plans, if a work is intended to be permanent
- ◆ Not have begun before an application for funding has been assessed
- ◆ Meet the below criteria, which are informed by the Whanganui District Council's Public Art Strategy 2010 – 2012 and Arts & Culture Strategic Plan 2019-2029.

Criteria:

Artworks must demonstrate at least one of the following:

- ◆ Artworks that shape and improve the perception, image and visual quality of Whanganui
- ◆ Artworks that reflect the history and culture of Whanganui
- ◆ Projects that recount oral histories of tangata whenua of the Whanganui region that have been validated and authenticated by at least two Iwi historians, who have been mandated by Whanganui Iwi organisations such as Te Runanga o Tupoho, Te Runanga o Tamaupoko & Te Runanga o Te Awa Tupua o Whanganui
- ◆ Projects that celebrate the visual language and design history of the whakairo tradition from Whanganui River marae and sites of significance
- ◆ Artworks that focus on Te Awa Tupua, the Whanganui River
- ◆ Artworks that celebrate and represent Whanganui's diverse communities through partnerships between artists and community groups
- ◆ Artworks that directly contribute to social and economic change in the Whanganui District
- ◆ Artworks that increase awareness of and participation in arts and creative cultural activity by Whanganui residents
- ◆ Artworks that take place in, on or nearby public infrastructure as part of development and redevelopment projects.

Priority will be given to proposals that:

- ◆ Are executed by local artists
- ◆ Demonstrate a high standard of artistic excellence
- ◆ Highlight considered responses to the proposed place or site that take into account cultural, environmental and historical contexts
- ◆ Consider accessibility of the project
- ◆ Utilise local tradespeople, as well as materials sourced or manufactured in Whanganui.

Process:

The Public Art Fund is delivered annually, unless there are funds remaining from a funding round. The Creative Community Advisor assists each applicant with their proposal before it is assessed to ensure the criteria are met and all the required supporting material is included.

Applications are assessed by the Public Art Steering Group based on the above criteria and in alignment with the Council's [Arts and Culture Strategic Plan 2019-2029](#).
