Whanganui District Council is seeking feedback on the review of the Streets Infrastructure Bylaw 2015. The Council is proposing changes to the drafting of the bylaw to improve its clarity and usability, but is not proposing any substantive changes to the rules relating to the Council's street infrastructure network and public places. The Council considers that an amended Streets Infrastructure Bylaw 2015 is the most appropriate way to manage and protect the Council's street infrastructure or public places and does not give rise to implications under the New Zealand Bill of Rights Act 1990.

# Rates relief consultation

Whanganui District Council has begun consultation on a rates relief package for people and businesses experiencing significant financial hardship as a result of COVID-19. The Council is proposing the ability to postpone rates upon application providing specified criteria have been met and an agreed payment plan is in place. This would allow ratepayers who meet the criteria an extra six months to pay their fourth-quarter 2019/20 rates, and the full year to pay their 2020/21 rates.
