5.1 HE IERE RANGATAHI - JAY REREKURA

Discussion

Mr Rerekura spoke about his role and the role of Nga Tai O Te Awa. He also outlined the recent history of collaborative activities in the youth sector in Whanganui. He lere Rangatahi is a living strategic document where youth workers have agreed to work towards shared goals.

Committee members asked Mr Rerekura for his thoughts on a proposed Youth Hub in Whanganui. He noted general support for the concept but his preference was for community hubs across the city rather than 1 central location. He supports any initiative that would provide young people with a sense of belonging in a safe, creative, and vibrant environment. The strategy document is similar to those used in other locations, but Mr Rerekura noted the Whanganui version was more 'organic' and involved less bureaucracy.
