Youth Councillors were given ten minutes to read the Child Protection Policy, as the intention to review the Child Protection Policy at the compulsory retreat but did not occur due to the low attendance numbers of Youth Councillors.

Kirsty Milham responded to questions regarding the following:

- The supervision criteria of children under the age of 12, particularly for events such as vibe. and Youth Connect.
- The importance of advertising the supervision requirements for events such as vibe. to ensure public awareness of the expectations.
- At an event such as Youth Connect students were required to complete a permission form that included parent signature.
- The Mayor should be informed of events organised by the Youth Committee involving Whanganui youth.
- It was questioned if point '19' should state 'Council', rather than 'Mayor'.

5.6 YOUTH COMMITTEE DRAFT BUSINESS PLAN 2019/20

Significance of decision – In terms of the Significance and Engagement Policy 2018, the decision is not significant.

Discussion

Claudia Perkins spoke to the tabled draft Business Plan 2019/20 (Ref 1) and noted the following:

Fine-tuning of the Business Plan and budget was required, due to the retreat finishing the
previous evening, technical issues and the expected costs of staffing and governance costs
was soon to be available.

ACTION – Claudia Perkins and Kim Fielder

- The Beach Clean-up category had been replaced by 'Climate Change'.
- Leaders of the Youth Connect 2019/20 would be sought in early 2020 as the event was anticipated to be held mid-2020. It was noted that the Youth Connect currently being organised, with Yth Cr Mia Perkins as the working party leader, was carried over from the 2018/19 Business Plan.

- Ideas under the Art category were to be sought, however the Youth Committee anticipated working collaboratively with Riah King-Wall, Strategic Lead Creative Industries and Arts. Yth Crs Brianne Drefko and Firooze Colaabavala requested to be in the working party.
- Advertising continued to focus on increasing public awareness of the Youth Committee, primarily via Facebook and Instagram as they both had different target markets. Yth Crs Brianne Drefko and Haris Khan would manage Instagram postings and Yth Crs Charlotte Hardy and Nikita Ebbutt-Moorhouse would manage Facebook postings. Yth Crs Brianne Drefko agreed to be the leader of the Advertising working party.
- Reduced budget had been allocated to Collaborative Community Events (CCE) funds due to a reduced number of applications. CCE would collaborate with Advertising to increase public awareness of the fund. Yth Crs Nikita Ebbutt-Moorhouse and Charlotte Hardy agreed to be the leaders of this working party.
- CY Support and Peer Support were new concepts. Confirming an action plan for these would be discussed at a future meeting.
- It was noted that the Youth Hub budget was \$200. It was considered sufficient to cover meeting costs as it's in the initial planning stage. Yth Cr Nikita Ebbutt-Moorhouse agreed to be a Youth Hub co-leader. The other co-leader was still to be confirmed.
- Administration budget had increased due to changes to the Governance Administrator role.
- Yth Crs Brianne Drefko, Firooze Colaabavala and Charith de Silva agreed to become vibe. working party leaders. The following sub-leaders of the vibe. working party were agreed:
 - Advertising Yth Cr Charlotte Hardy
 - Stalls Yth Cr Nikita Ebbutt-Moorhouse
 - Technical Support Yth Cr Haris Khan
 - Music Yth Cr Sophie Archer
 - Funding Yth Cr Mia Perkins
 - Activities Yth Cr Jonty Tripe
 - Health and Safety Council officers
