**RESERVED DECISION OF THE WHANGANUI DISTRICT LICENSING COMMITTEE**

**1. Application**

**Brett Hutchins** made the application on the prescribed form received on 20th February 2020. The applicant intends using the certificate at Black Bull Liquor (Off Licence), where the applicant has been working for over 12 months. The application included evidence of obtaining the necessary License Controller Qualification and a letter from their employer attesting to their experience and skills. The applicant has incurred a drink driving conviction however it is historical and the inspector believes irrelevant now to this application.

**2. Decision Making**

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- *a) the applicant's suitability to be a manager:*

- (b)any convictions recorded against the applicant;
- (c)any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force;
- (d)any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#);
- (e)any matters dealt with in any report made under [section 220](#).

### **3 Reporting Agencies**

The following reports were received under section 220 of the Act and taken into account during the decision.

**3.1 Police** – No opposition within report dated 2 March 2020.

**3.2 Licensing Inspector** – Full report assessing **Brett Hutchin**'s credentials against the Acts criteria. The inspector has interviewed the applicant and concludes that the application is complete and appears to meet the criteria of section 222 of the Act.

### **4 Conclusion**

Based on the evidence provided to me within the application and statutory reports I conclude that **Brett Hutchins** meets the criteria to hold a Managers Certificate under the Act.

### **5 Decision**

Accordingly the application is **Approved** for issue for a period of one year.
