DECISION OF THE WHANGANUI DISTRICT LICENSING COMMITTEE

1. Application

Dawn Harallambi made the application on the prescribed form dated 13 September 2024. The applicant intends using the certificate at Te Whare o Rehua Sarjeant Gallery (New Café On-licence), where they intend to be employed.

The applicant was previously employed in the hospitality sector in the Ruapehu (Utopia Café) area where she was formally a Certified Manager. Dawn Harallambi was the owner and licensee of the Utopia Café for approximately fifteen years where she provided hospitality services in keeping with licensed café services. The Manager's Certificate has since expired.

The application included evidence of obtaining the necessary License Controller Qualification. The applicant's employer gave evidence of the applicant's experience, skills, and suitability.

2. Decision Making

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- *a) the applicant's suitability to be a manager:*
- *(b) any convictions recorded against the applicant:*
- *(c) any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*
- *(d) any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- *(e) any matters dealt with in any report made under [section 220](#).*

3 Reporting Agencies

The following reports were received under section 220 of the Act and taken into account during the decision.

3.1 Police – No opposition within report dated 17 September 2024.

3.2 Licensing Inspector – Full report assessing **Dawn Harallambi's** credentials against the Acts criteria. The inspector has interviewed the applicant and concludes that the application is complete and appears to meet the criteria of section 222 of the Act.

4 Conclusion

Based on the evidence provided to me within the application and statutory reports I conclude that **Dawn Harallambi** meets the criteria to hold a Managers Certificate under the Act.

5 Decision

Accordingly, the application is **Approved** for issue for a period of one year.
