**RESERVED DECISION OF THE DISTRICT LICENSING COMMITTEE**

**1. Application**

Hollie May Tindale made the application on the prescribed form received on the 1st March 2018. The applicant intends to use the certificate at the Midtown Motor Inn (On-licence), where the applicant has worked behind the bar for approximately 9 months. The application included a character reference from her employer, attesting to experience in the industry and suitability.

The applicant has attained the relevant License Controller Qualification and has no declared convictions.

**2. Decision Making**

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- *(a) the applicant's suitability to be a manager:*

- *(c) any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*
- *(d) any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- *(e) any matters dealt with in any report made under [section 220](#).*

### **3 Reporting Agencies**

The following reports were received under section 220 of the Act and taken into account during the decision.

**3.1 Police** – No opposition within report dated 23<sup>rd</sup> March 2018.

**3.2 Licensing Inspector** – Full report assessing Hollie May Tindale credentials against the Acts criteria. The inspector has interviewed the applicant and is satisfied that the applicant has the necessary knowledge to hold the certificate.

The inspector concludes that the application is complete and records no opposition to the granting of the application.

### **4 Conclusion**

Based on the evidence provided to me within the application and statutory reports I conclude that Hollie May Tindale meets the criteria to be granted a Managers Certificate in accordance with the Act.

### **5 Decision**

Accordingly the application for manager's certificate is **Approved** for issue for a period of one year.
