RESERVED DECISION OF THE DISTRICT LICENSING COMMITTEE

1. Application

John Leitrim Henderson-Newport made the application on the prescribed form received on the 11th July 2018. The applicant intends to use the certificate at the Shotz Bar (On-licence) and Station United Sports Club where the applicant is currently working. The applicant's current employers gave references for the applicant and the application included evidence of experience gained in the industry.

The applicant has attained the relevant License Controller Qualification. Although the applicant has incurred convictions in the past they have not been for a few years now and none of the reporting agencies have raised concerns in this regard..

2. Decision Making

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- *(a) the applicant's suitability to be a manager:*
- *(b) any convictions recorded against the applicant:*
- *(c) any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*

- *(d)any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- *(e)any matters dealt with in any report made under [section 220](#).*

3 Reporting Agencies

The following reports were received under section 220 of the Act and taken into account during the decision.

3.1 Police – No report within statutory timeframe therefore assume there is no opposition.

3.2 Licensing Inspector – Full report assessing **John Leitrim Henderson-Newport**'s credentials against the Acts criteria. The inspector has interviewed the applicant and is satisfied that the applicant has the necessary knowledge and experience to hold the certificate.

The inspector concludes that the application is complete and records no opposition to the granting of the application.

4 Conclusion


