**RESERVED DECISION OF THE WHANGANUI DISTRICT LICENSING COMMITTEE**

**1. Application**

**Sanjay Gadiyar** made the application on the prescribed form dated 14 October 2022. The applicant intends using the certificate at 'Liquorland', Bottle Store Style Off-licence, which he purchased and has a few months experience working in. Additionally the applicant has spent twelve years in the industry.

The application included evidence of having obtained the necessary License Controller Qualification and declared they have no convictions.

The applicant's employer gave evidence of the applicants experience, skills and suitability to hold a licence.

**2. Decision Making**

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- *a) the applicant's suitability to be a manager:*

- *(c) any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*
- *(d) any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- *(e) any matters dealt with in any report made under [section 220](#).*

**3 Reporting Agencies**

The following reports were received under section 220 of the Act and taken into account during the decision.

**3.1 Police** – No opposition recorded.

**3.2 Licensing Inspector** – Full report assessing **Sanjay Gadiyar's** credentials against the Acts criteria. The inspector has interviewed the applicant and concludes that the application is complete and appears to meet the criteria of section 222 of the Act.

**4 Conclusion**

Accordingly based on the evidence provided to me within the application and statutory reports I conclude that **Sanjay Gadiyar** meets the criteria to hold a Managers Certificate under the Act.

**5 Decision**

Accordingly the application is **Approved** for issue for a period of one year.
