**RESERVED DECISION OF THE DISTRICT LICENSING COMMITTEE**

**1. Application**

Vishnu Pal Singh Rautela made the application on the prescribed form received on 20<sup>th</sup> April 2016. The application included the applicant's qualifications and industry experience. The applicant has been employed at Spice Guru Restaurant where he intends using the certificate.

The applicant has attained the relevant License Controller Qualification and has not incurred any convictions.

**2. Decision Making**

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- *a) the applicant's suitability to be a manager:*
- *(b) any convictions recorded against the applicant:*
- *(c) any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*
- *(d) any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- *(e) any matters dealt with in any report made under [section 220](#).*

### **3 Reporting Agencies**

The following reports were received under section 220 of the Act and taken into account during the decision.

**3.1 Police** – Report of no objection received on 10th May 2016.

**3.2 Licensing Inspector** – Full report assessing Vishnu Pal Singh Rautela credentials against the Acts criteria. The inspector has interviewed the applicant and is satisfied the applicant had the necessary knowledge. The inspector is satisfied that the applicant has sufficient knowledge and experience to hold the certificate.

The inspector concludes that the application is complete and appears to meet the criteria under s.222 of the Act.

### **4 Conclusion**

Based on the evidence provided to me within the application and statutory reports I conclude that Vishnu Pal Singh Rautela meets the criteria to be granted a Managers Certificate in accordance with the Act.

### **5 Decision**

Accordingly the application for manager's certificate is **Approved** for issue for a period of one year.
