**RESERVED DECISION OF THE DISTRICT LICENSING COMMITTEE**

**1. Application**

Alannah Raewyn Parkes made the application on the prescribed form received on the 8th September 2017. The applicant intends to use the certificate at the Castlecliff Bowling Club (Club-licence), where the applicant will work. The application included a reference from the applicant's previous employer attesting to past experience in the industry.

The applicant has attained the relevant License Controller Qualification and has not incurred any convictions.

**2. Decision Making**

In considering this application for a manager's certificate the licensing committee had regard to the following criteria under section 222 of the Act.

- *(a) the applicant's suitability to be a manager:*

- *(c) any experience, in particular recent experience, that the applicant has had in controlling any premises for which a licence was in force:*

- *(d)any relevant training, in particular recent training, that the applicant has undertaken and evidence that the applicant holds the prescribed qualification required under [section 218](#):*
- *(e)any matters dealt with in any report made under [section 220](#).*

### **3 Reporting Agencies**

The following reports were received under section 220 of the Act and taken into account during the decision.

**3.1 Police** – Report submitted on 13 September 2017 stating no opposition to the application.

**3.2 Licensing Inspector** – Full report assessing Alannah Raewyn Parkes credentials against the Acts criteria. The inspector has interviewed the applicant and is satisfied that the applicant has the necessary knowledge and experience to hold the certificate.

The inspector concludes that the application is complete and records no opposition to the granting of the application.

### **4 Conclusion**

Based on the evidence provided to me within the application and statutory reports I conclude that Alannah Raewyn Parkes meets the criteria to be granted a Managers Certificate in accordance with the Act.

### **5 Decision**

Accordingly the application for manager's certificate is **Approved** for issue for a period of one year.
