# 1. Application

The inspector has interviewed the applicant twice and is now satisfied that the applicant has the necessary knowledge and experience to hold the certificate provided the applicant signs an undertaking to limit the certificate to the MV Waimarie for the first year.

The inspector concludes that the application is complete and records no opposition to the granting of the application.
