

Annual Plan building for the future

Whanganui District Council is seeking public feedback on its Annual Plan 2019/20.

A Consultation Document, adopted on Tuesday, 12 March, identifies one key change in regards to Whanganui Port from the Long-Term Plan 2018-2028 and provides information on other projects and changes to funding since the Long-Term Plan was adopted.

Among these projects is a proposal to allocate \$80,000 to develop and implement a heritage strategy.

This would provide the Council, working in partnership with the community, with a framework to manage and protect the district's heritage assets including our oral, written and physical legacy.

An average rate increase of 3.9% is also proposed, although individual property increases could vary significantly depending on how rates are assessed for a property. For the farming sector the proposed increase is 4.6%.

Proposed changes to fees and charges outlined in the Consultation Document include an increase in residential and commercial LIM costs, and a flat increase of 50c for swimming pool entry fees.

Matipo Community Development Charitable Trust scooped the Supreme Winner award at the Trustpower National Community Awards held in Tauranga on Saturday, 30 March 2019.

The Castlecliff-based Trust is a not-for-profit organisation dedicated to making social change through education and employment. Trust volunteers have transformed a swampy wasteland once covered in weeds into cultivated community gardens that provide food for locals and is a hub for horticulture and literacy education.

The Supreme Winner decision was made by a panel of independent judges together with each of the award's 26 contesting groups after a full day of viewing presentations.

"The fact that the overall winners are endorsed by their peers makes this award all the more special. The work done by volunteers across New Zealand is really impressive," Matipo Trust Chair Rosemary Rippon said.
