

# Fun and games just common sense

On recent walks along Ridgway Street you may have been surprised to see people playing games – such as table tennis, giant Connect 4 and giant Jenga – in the open air.

In late November Paul Fletcher, of The Common Ground, opened a new "pop-up" café in a renovated shipping container on a piece of unused ground at 45 Ridgway Street, and the outdoor games are set up in front of the café. The café will be in place for six months.

Mr Fletcher says, "The commons, back in the day, was a public space where people gathered. We're hoping to create just that sort of space – we would like this site to be a shared one, with everyone and anyone welcome to come and use the outdoor games."

Ellen Young, Whanganui District Council's Town Centre Regeneration project manager, says, "A core part of the Town Centre Regeneration Strategy is to create more activity in our central city spaces and provide young people with something to do, so it's great to support this project as it really fits the bill."

As well as providing a space to benefit the community, Mr Fletcher says The Common Ground also exists to provide local young people with "work experience in a highly supportive environment" and hopes to transition them into full-time employment. There are three young trainees at the moment

Open from 7.30am-3.00pm Monday to Friday, the café is a non-profit business – 100 percent of any profits will be directed into community projects for young people.



Consultation is now open on changes to speed limits on Castlecliff Beach, and Rapanui and Francis roads. Have your say

Whanganui District Council is reviewing the speed limits on Castlecliff Beach and is proposing to reduce the speed limit from 100km/h to 30km/h.

Also included in the proposed amendment is a reduction in the speed limit around Westmere School and on Rapanui Road, from Westmere School to State Highway 3, from 100km/h to 80km/h.
