Dear Councillors and Mayor

Few in our community recognize the personal cost to yourselves, the unique challenges this election term brings. But I do. Thank you.

Many believe the outcome is predetermined, consultation purely an exercise and hasty at that.

I share this concern, particularly with regard to Councillors who openly hold views that an individual's race should be the dete1mining factor in selection for leadership. In my opinion an archaic viewpoint which evolved (egalitarian) societies do not hold.

Apologies for my lengthy submission but is a sad day when New Zealanders must provide sufficient inarguable reasons to retain racial equality for all citizens.

October 24th 2023, 13 people - without public mandate & support - can impose democratic change which cannot be overturned by community majority.

I oppose the introduction of Maori wards - which blatantly denies the right to full seat representation for all citizens - both in Whanganui and throughout New Zealand for the following reasons:-

Online dictionary established 2001 NZ Government's Ministry for Culture and Heritage "The Royal Commission on the Electoral System, established 1985, gave considerable thought to the future of the Maori seats. It's 1986 report concluded that separate seats had not helped Maori and that they would achieve better representation through a proportional party-list system. The commission the1 efore recommended that if it's favored mixed member proportional (MMP) system was adopted, the Maori seats should be abolished."

1993 following a national referendum. MMP adopted.

Maori seats retained through lobby groups. At each election different campaigns promise to remove seats. 2023 is no exception.

The public are NOT informed

I have canvassed throughout Whanganui District, both rural and city, people from all walks of life. Despite the best efforts of our Democracy Officer few people, other than lwi, are aware Council are asking for submissions. You saw my letter to the Chronicle.

With referendum denied, unless unquestionable data proves otherwise, Council members must assume that voters expectation is for elected Councillors to honor and retain the status quo ensuring Whanganui citizens retain their individual, equal right, to vote for ALL 12 seats and Mayor. Of the few informed most stated submissions were in their experience pointless, consultation token. Disillusioned.

Announcements, predominantly online, have excluded too many of our foundation members who over decades have paid for and maintain our infrastructure. However targeted groups, Iwi, Hapu, Kaumatua Kaunihera, etc are fully informed.

Democratic rights of the individual

It is ironic that Councillors in exercising their own democratic power will remove the right of others. Forever changing the rights of every member in this community both Maori and non Maori.

Your <u>personal</u> vote as a Councillor cannot be overturned by public referendum, forever recorded in this country's history.

Due to Local Electoral (Maori Wards and Maori Constituencies) Amendment Act 2021, Minister for Local Government Nanaia Mahuta,

A public referendum cannot overturn Council imposing Maori Wards. Few submitters will know this.

At last election Council were not given the mandate to alter local democracy

Maori Wards were not on the table. Therefore Councillors and Mayor have not been given the mandate to alter local democracy.

On that basis **Councillors who vote October 24th to implement Maori Wards will be expressing their personal view - not that of this community.**

Mayor Andrew Tripe campaigned to protect and retain local democracy. That expectation must be honored.

Co governance was discussed with many elected councillors pledging to uphold democratic selection rejecting race determined appointments or systems.

<u>Councillors who mistakenly believe that Maori are not elected to Council due to racism reflect their</u> <u>own unsubstantiated personal bias</u>

This view is insulting to past and current Councillors and Mayors, elected without the benefit of Wards. Both Maori and non Maori alike.

Views like this diminish the contributions of all Maori Parliamentarians, Acting Prime minister James Carroll (1909 & 1911), Ralph Love, Sir Apirana Ngata, Moko Tepania, Tory Whanau amongst many Maori elected who have worked and strived for their communities.

People of profile and calibre, inespective of race, are elected to lead communities, demonstrated by history.

Mostly it *is* a slur on this community. Offensive to people like myself. At each election I have chosen Maori candidates - not because of race - but because of confidence in that candidate's suitability.

Finally, look to your own voting papers at the last election and determine what your own selections were based on.

It is of concern that Councillors who hold views about racism might seek to appease their conscience by voting in support of Maori Wards unaware they are acting in a paternalistic manner.

Paternalistic because Maori Wards manipulate outcomes by reducing competition and full democratic right of Maori roll voters from representation of 12 seats down to only 2, with corresponding reduced candidate choice.

Councillors who believe Maori will never be elected without Maori Ward manipulating voting outcomes should look to history.

1893 suffrage

1919 Women can run for Parliament- many believed women would not be elected.

1933 Elizabeth McCombs - first

1949 Iriaka Ratana - first

2023 women make up 61% of Parliament, Party leaders, Governor General,

<u>Descendants of Maori who prefer representation - only by their own race - must stand.</u> <u>Maori who demand same race representation - need to exercise their vote</u>

It is as simple as that. We do not hobble horses in races so why should Maori lose 10 seat representation to reduce competition for candidates?

Data reflects that Maori descendants have (historically) poor voting rates. Our aim should be to increase engagement not limit selection further.

To say that Maori residents have no voice here in Whanganui is false

Councillors believing that by taking 12 seats leaving 2 they are giving a voice to Maori should acknowledge these voices

Te Awa Tupua a world first and of national significance - Te Pou Tupua, Gerard Albert Our district recently boasted nationally of Te Puwaha collusion Nga Tangata Tiaki O Whanganui Tupoho Kaumatua Kaunihera Maori Women's Welfare League Tamaupoko (TCLT) Whanganui Land Settlement Trust Pahia Turia until recently a leading figure at Whanganui & Partners Harete Hipango, Tariana Turia, Adrian Ruruwhe, amongst many Ratana church members Other groups of equal significance

And Individuals who, like myself, have full access to a dedicated Council team

I have every confidence that this Council strives to enhance and improve cohesion and dialogue with ALL members of this community including Maori who whakapapa to this District. All are served equally by each one of the elected Councillors without regard to race, sex, age, religion etc.

Central government initiative not community initiative

Maori Wards are a central government party policy delivered by LGNZ and the LG Commission, a statutory body.

Not community initiated.

Policy not law. Therefore not compulsory. We have our systems in place.

Hasty timeframe suggests central government majority party are utilizing local government to implement and embed a political party policy 'interpretation' of Te Tiriti - not universally held or agreed to.

LGNZ (without consultation of members) were signatory to a HOA with Nanaia Mahuta to not oppose 3 Waters - now mandated against overwhelming opposition (800,000 in opposition). Along with other breaches of democracy.

No public referendum offered or allowed with few aware of the 2021 Act amendment - **Outrage is** guaranteed - Intensified by it being subsequent to the event.

It is imprudent, bordering on destructive, for 13 people to impose race based seats given the lack of community knowledge, lack of expected referendum and limited time frame for consultation.

Councillors will lose public trust.

Due diligence, education and comprehensive consultation seeking community support prior to the next elections will retain community harmony not intensify existing public distrust of government due to mandates and other perceived breaches of democracy.

Distrust and disillusionment will increase lack of engagement

46% at last election. Data supp01 is Maori voter turnout is extremely poor.

Wards are tangible evidence of racial division. As are the two flags which have been (recently) flown daily outside Council.

Should Council impose Wards, then incoming government remove, there will be unnecessary community conflict, disharmony, resentment, loss of faith in local government. Rifts which may take years to heal.

Amongst Maori roll voters there is confusion that it is similar to Te Tai Hauauru. General roll are mostly oblivious.

Successful election of candidates to Council is based on

Candidate having an existing voting base & support - family, friends, associates High public profile - social, business, cultural, religious & group affiliations Election time enhanced voter familiarity Personal promotion, cost, billboards, online etc Known & past performance Perceived suitability & competence - public meetings, newspaper, etc Ratepayer vested interest Religious and ethnic association - Ratana, Iwi, community mana, community affiliations

Data shows poor Maori descendant voter turn out

Apathy - Do not attribute more to any apathy you may have observed than what it is - not inter-generational grief, it is simply people getting on with their lives, concerned about cost of living etc - assured others have the helm,

Disinterest - also expressed in general population by 46% turnout last election

Tribal love - Te ao Maori is a traditional whakapapa lineage system, Ariki and Rangitira rule with majority living as noa Maori within a class system

Youthful population- Statistics show those descended from Maori have a higher percentage of youthful population - ineligible to vote

Eligible youth - often less engaged

Disheartened - shared by general population expressed by poor voter turnout and Council engagement **Many not enrolled** - youthful, transient, tenant, etc

Poor Voter confidence reflected in low vaccine rates amongst Maori reported by government resulting in lockdowns, business mandates, resignations and dismissals, etc. increased distrust.

Maori roll is a subset not inclusive of all Maori descendants

As in my own family, many prefer the general roll because it offers increased choice.

Smaller subsets created by Maori Ward seats include

Iwi affiliation Hapu affiliation Local and outside Maori descendancy Lobby groups Political party affiliations Religious affiliation e.g. Ratana Partial loyalty or full loyalty to affiliations will impact on voter selections risking lobby rather than true representation

<u>Conflicts and differences in tikanga reflect there is no one "Maori lens" just as there is no one "pakeha lens"</u>

Maori Wards introduce race based inequity and inequality of representation

Just as I do not speak for my own demographic neither does one Maori representative speak for all Maori. To believe othenvise is naive bordering on racism

Maori on the Maori roll - reduced from 12 seats - to only 2 (loss of 10) Non Maori on general roll - reduced from 12 seats - to only 8/10 (loss of 2/4) Maori descendants on general roll from 12 seats - to only 8/10 (loss of 2/4)

Both Maori and non Maori on general roll condemned to NEVER have right to vote for Maori (unless candidate standing on general roll)

Maori roll condemned to never vote for non Maori on general roll - law does not allow (despite personal preference and confidence)

History shows we are regressing not prog1-essing

1893 NZ women first in the world to vote. Maori women can only vote for Maori seats. Men only.
Laws 1893 and 1896 completed almost full separation of Maori and European election systems
1893 to 1919 James Carroll (Maori) held a general seat/ 1909 & 1911 acting Prime Minister NZ
1919 women able to run for Parliament - 3 candidates stood, Ellen Melville placed 2nd out of 5 in Grey Lynn

1933 first woman in parliament Elizabeth Mc Combs

1949 First Maori woman, Iriaka Ratana, elected to Parliament

1967 Maori able to stand in general election

1993 MMP chosen in general referendum.

2023 Maori Wards= Maori women on the Maori roll can only vote for Maori

In just 130 years our women return to Maori only selection possibly men only unless women stand.

Maori women will no longer have full representation of 12 seats. Nor will Maori men.

Council would be reintroducing an archaic election system embedding a race based roll system into local government.

<u>Under the current democratic system Maori women, regardless of roll selection, have the right to vote</u> for all 12 seats.

That right must remain.

Individuals should not have to choose between rolls, 2 or 8/10 seats

2023 Maori women must have full representation at local government level. As must Maori men.

Maori Wards at local government are Labour Party undeclared policy

Attorney General, Sir Geoffrey Palmer introduced the "Five Principles for Crown Action on the Treaty of Waitangi" in 1986 to make it easier for the Waitangi Tribunal to settle claims. While it appeared in our Law, they were not made public until 3 years later. The Principles were based on both Freeman's compiled English version of the the Treaty of Waitangi and the Tiriti o Waitangi that had only one Principle, "He iwi tahi tatou- We are now one people".

The Principes were to help settle claims between the Crown and Maori without any consideration to non-Maori, except to pay the settlements or give up valuable public assets. Maori were never the first people to a1 Tive here in New Zealand, They came after the Pungapunga, Turehu, Patupaiarehe, Ngati Hotu,, Waitaha

These were the true indigenous people. Tangata Whenua.the true meaning is (The ancient ones, or the people before us).

The spoken Language was Maori, the written language wasEnglish.

Thanks for the reminder. Here is our feedback:

The Maori population is 26% of Whanganui city

The electoral turn out for the whole of Whanganui was 46 percent

Maori voter turn out is historically low across the country

If the majority of Maori in Whanganui voted it has the power to decide the election

Our view is that strong representation on Maori seats would have a significant effect on voter turn out it would also make decision by the council more in line with how our people think

District and regional council have significant powers and their decisions are arguably more impactful on things we care about

Our view is that Patutokotoko should support Maori seats but we recognise this is a significant change and requires more than a feedback email type of engagement process. Our advice is to contact Maori Ward councillors cunently in place throughout the country to come and speak to hapu and iwi to better understand how they fulfil their role and give greater voice to hapu, iwi and Maori in within our democratic system.

There is a current debate that the risk of Maori wards is it takes out the need for hapu and iwi. This is not the case from our perspective but there needs to be an educational aspect leading into the decision.
