Note: this notice relates to sites either designated by Chorus New Zealand Limited, Telecom New Zealand Limited, or both, as set out in the schedules in Appendix A.

1 Notice of Requirement

Pursuant to Clause 4 of the First Schedule of the Resource Management Act 1991, Chorus New Zealand Limited (Chorus), and Telecom New Zealand Limited (Telecom) hereby give notice that the designations allowing for telecommunication and radiocommunication works as described below (being designations that have not lapsed) are required to be included in the Proposed Wanganui District Plan.

This notice applies to those designations of Chorus and Telecom currently included in the operative Wanganui District Plan.

The designation purpose shall be *Telecommunication* and *Radiocommunication* and *Ancillary Purposes*. This is a standardised notation being sought for all Chorus and Telecom sites nationally.

The relevant requiring authority for each site is set out in the schedule in Appendix A.

2 Description of the sites to which this Notice applies

The sites to be designated in the Proposed Wanganui District Plan are those existing Chorus and Telecom designations contained in the operative Wanganui District Plan. The legal descriptions of these sites are contained in the schedule in Appendix A. However, in summary they include the following designated sites:

These are all long established telecommunications sites that have been given effect to.

At midnight on 30 November 2011, Chorus and Telecom demerged into two separate companies. How existing Telecom designations were to be treated after that time was dealt with in the Telecommunications (TSO, Broadband, and Other Matters) Amendment Act 2011. Under that Act, a new Section 69XI was inserted into the Telecommunications Act 2001 approving Chorus as a requiring authority under the Resource Management Act 1991 (RMA).

Further, a new Section 69XJ was inserted allowing that before separation day, the Minister for Communications and Information Technology may, by way of Gazette notice, issue 2 lists comprising all or any of the designations for which Telecom is responsible as follows:

- (a) Designations that are to be transferred to Chorus; and
- (b) Designations that are to be additionally granted back to Telecom.

The transfer of the designations in the Wanganui District Plan to Chorus, and those which also have a secondary designation granted back to Telecom, as

set out in the table above, reflect the lists that were included in the Gazette notice (New Zealand Gazette Notice number 8265, 2011, page number 5151) prior to separation of the companies. A copy of the Gazette notice has previously been provided to the Council, and is therefore not attached to this Notice. Telecom no longer differentiates in its designations between Telecom New Zealand Limited and Telecom Mobile Limited.

Telecom was granted requiring authority status in New Zealand Gazette Notice number 9577, 1993, page number 3366.

It is noted that all of the designations listed in the table above are correctly shown in the operative plan as Chorus designations. However, the secondary designation by Telecom over Designation 197 is not currently included shown in the District Plan and this needs to be rectified.

3 Nature of the Proposed Works

The designations all relate to well established telecommunications sites which are strategic assets of the Chorus and Telecom networks. Designation of these existing facilities is required to ensure the on-going security and resilience of essential services, and to provide for flexibility for the networks to adapt to changing technologies and community expectations.

A range of different equipment may be required on these sites to support telephone and internet services which may be by fixed line and/or wireless means. This may include:

- A building for housing equipment
- · A mast or masts to support antennas
- Antennas
- Back up electricity generators (engine alternators) and associated diesel fuel storage
- · Air conditioning plant
- · On-site parking for technicians

These sites will require ongoing maintenance, upgrades and replacement of equipment and other ancillary works as necessary and as required for the continued provision and evolution of telecommunications and radiocommunications services to meet the needs of the community and to support a modern knowledge economy.

4 Proposed Modifications and the Effects of any Modifications on the Environment

Designation Purpose

To provide a level of national consistency with other Chorus and Telecom designated sites throughout the country, Chorus and Telecom require that the designation purpose for all designations subject to this notice shall be "Telecommunication and Radiocommunication and Ancillary Purposes". This will cater for the full range of modern telecommunications operations, including wireless and internet based services.

Currently the designation notation is "Telecommunication and Radiocommunication Purposes". The addition of the words "and Ancillary" will also provide flexibility for minor associated works to be undertaken. It is noted that the outline plan process allows for the consideration of any specific project design and the associated environmental effects should there be any additional external works proposed for the designated sites in the future.

A list of all the designations (in the format currently provided in the online district plan), with the proposed modification to the designation purpose (underlined text) is provided as Appendix A.

5 Minor Corrections

There are several minor corrections also underlined in the schedule in Appendix A. They include:

- The identification of Telecom as being the secondary requiring authority for Designation D197 as set out in New Zealand Gazette Notice number 8265, 2011, page number 5151. This does not appear to have been included at the time that notification was given to the Council of the transfer of the designations as per the gazette notice.
- The inclusion of the Certificate of title references in with the legal description for each site for completeness; and
- A correction to the map references for D191 and D202 to include the Rural Map numbers for completeness.

It is considered that these changes are not modifications to the designation, as they do not alter the nature of the designation or the extent of the site.

6 Alternatives

As the requirement relates to existing telecommunication and radiocommunication sites, a consideration of alternative sites has not been undertaken.

The principle alternative method would be to not designate the sites, which is not favoured as it would not give Chorus or Telecom the long term certainty it requires for ongoing operation and upgrading of these sites.

7 Consultation

As the requirement relates to sites with telecommunication facilities that have been established for some time, no specific consultation has been undertaken at this stage. The proposed modifications will be publicly notified as part of the Proposed District Plan process.
