NEW ZEALAND RAILWAYS CORPORATION DESIGNATIONS FOR PROPOSED WANGANUI DISTRICT PLAN PURSUANT TO SCHEDULE 1, CLAUSE 4(1) OF THE RESOURCE MANAGEMENT ACT 1991

The New Zealand Railways Corporation (NZRC) confirms that we wish to retain and rollover <u>Designation D204 for Railway Purposes</u> into the next generation Proposed Wanganui District Plan. The NZRC also seeks minor corrections to its railway designation as part of this rollover.

Firstly we seek for Council to update the name of the requiring authority for the D204 designation to the New Zealand Railways Corporation.

Secondly we require Council to rectify a minor cartographical error within the railway designation as it is recorded within the Operative District Plan's Planning Maps. Specifically we seek a minor correction to include a parcel of NZRC owned land adjacent to Taupo Quay. This parcel of land is highlighted within the enclosed GIS electronic dataset.

In support of our request to rollover Designation *D204* with minor corrections, we have prepared an electronic data set to accompany this application. The dataset has been captured in our MapInfo based GIS software and supplied to Council in MapInfo Tab format. Please note that this data is projected in New Zealand Transverse Mercator format.

Council may note some minor offsets between our data and the underlying cadastre. This is a result of discrepancies within Land Information New Zealand's Core Record System. We appreciate that this may cause some confusion, but we wish to assure Council that it is not our intention to designate neighbouring third party land.
