Wanganui District Plan Review- Rollover of Police Designations

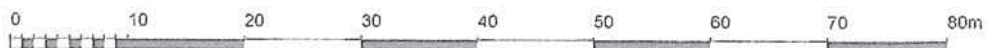

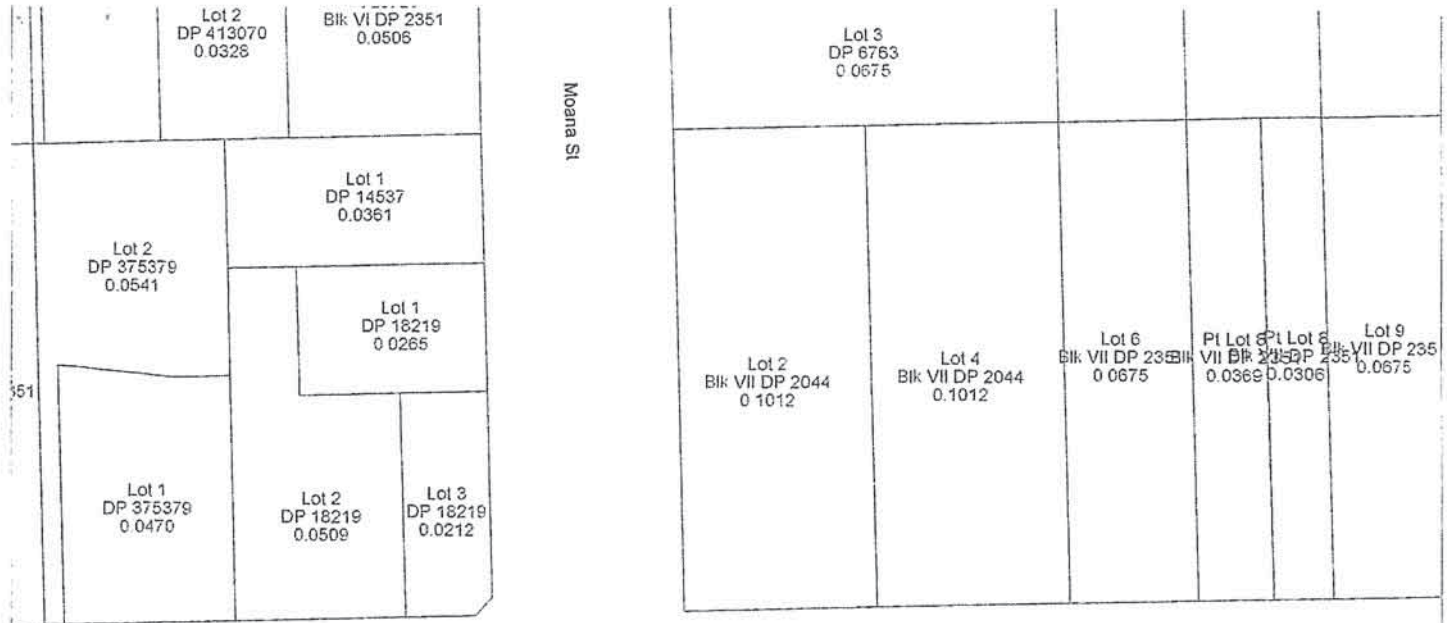

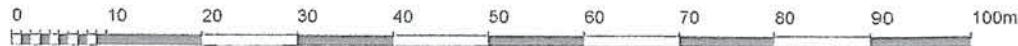

Wanganui East Community Police Station



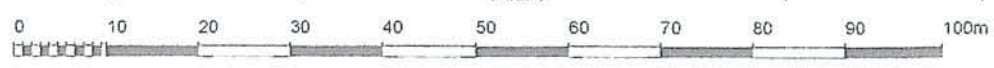

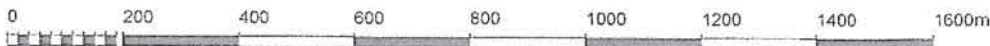
