PPC39 (Archaeology) updates archaeological sites in the District. Information about known sites has been refined, the location of some sites has been corrected and new sites have been identified. PPC47 (Land Stability Assessment Areas (LSAA) (Stage 3) Mowhanau and Roberts Ave/ Paterson St) incorporates sites susceptible to land instability hazards into the Land Stability Assessment Areas (LSAA) overlay on the District Planning maps and includes assessment and regulation of any development on those sites, to protect the property and the surrounding area.

Public Participation Process

The process for public participation in the consideration of the proposal under the Act is as follows:

- After the closing date for submissions Council must prepare a summary of decisions requested by submitters and give public notice of where the summary and submissions can be inspected; and
- Any person may make a further submission in support of, or opposition to, the submissions already made.
- If any person making a submission asks to be heard in support of his or her submission, a hearing must be held; and
- Council must give its decision on the provisions and matters raised in the submissions (including its reasons for accepting or rejecting submissions) and give public notice of its decisions within 2 years of notifying the proposal and service it on every person who made a submission at the same time; and
- Any person who has made a submission has the right to appeal against the decision on the
 proposal to the Environment Court if, the persons submission referred to the matter for which
 an appeal is to be lodged; and the appeal does not seek the withdrawal of the proposal as a
 whole.
