8.1 ADOPTION OF COUNCIL ANNUAL REPORT FOR YEAR ENDED 30 JUNE 2019

Discussion

Prior to the Council's Annual Report presentation, Mike Fermor (General Manager Finance) acknowledged the retirement of the Council's long-serving Management Accountant, Mike Brennan and the appointment of Wieham Labuschagne, originally from Tararua District Council.

Mr Fermor advised that other than a small change within the deferred tax calculations, there were no material changes in the report provided to Elected Members. Referring to the report's summary, Mr Fermor said financially the Council had performed well with effectively a break-even rates funded balance and a debt balance of \$99.75M compared to a budgeted debt balance of \$116.37M. A signed copy of the 2019 Management Representation letter to Council was available if requested.

Debbie Perera (Audit Director) acknowledged the Council's Finance Team. The team had undertaken a significant amount of work to enable the Council to be in a position to adopt its annual report much earlier than the end of October.

Mrs Perera provided a summary of Audit New Zealand's focus this year and said part of her role was to ensure the Council was reporting fairly and providing the correct information.

Mrs Perera said she was in a position to provide the Council with an unmodified audit opinion from Audit New Zealand for its 2019 Annual Report.

Mrs Perera and Mr Fermor responded to Elected Members' questions of clarification.
