# RESERVED DECISION OF THE WHANGANUI DISTRICT LICENSING COMMITTEE

#### Application

- (1)The application was made on the 19 January 2020 on the prescribed form. The application seeks to vary an existing on-license to reduce the existing licensed footprint in order for a neighbouring licensee to extend their licensed footprint. This is well explained in the Inspectors Report. The existing premises is at 1-5 Maria Place and 98 Victoria Avenue, Whanganui.
- (2) The variation will remove the applicant's rights to be licensee over 98 Victoria Avenue, an area currently vacated by the applicant with tenure extinguished. The variation is against On-Licence 036/ON/011/2016.

## **Decision Making**

(3) In considering this application for On-Licence the District licensing Committee (here in after referred to as the 'Committee') had regard to the criteria specified under s. 120/105 of the Act.

## Reporting Agencies

- (4) The following reports were received under section 103 of the Act.
- (5) **Police** Report received on 10 March 2021, offering no opposition.
- (6) Medical Officer of Health Report received on 15 April 2021, offering no opposition.

## (7) Licensing Inspector

Full report dated 20 April 2021. The inspector provided a comprehensive report into the application, has met the applicant and concluded that the application is complete, appears to meet the criteria for a variation of on-licence and therefore has no opposition to the application. The inspector has recommended possible conditions.

#### Committees Decision and Reason

- (8) Based on the evidence provided to me within the complete file, lack of opposition from the relevant agencies, my assessment of s.105 criteria, I conclude that the application meets the criteria under the Act to be granted a variation of on-licence as sought for the premise situated at 1-5 Maria Place and 98 Victoria Avenue, Whanganui and known as "Mint Café and Frank Bar".
- (9) Accordingly the application is **approved** for issue until the **8th day of November 2022** (being the existing term) subject to the conditions identified in the Inspectors report.
