## What you need to know

- The information requested in this form is needed to register your dog(s). You must notify Whanganui Council of any change of address or change in ownership of the dog(s).
- Your date of birth is required by the Act; it enables Whanganui Council to distinguish you from other persons with the same name.
- If your dog is neutered please provide a copy of a veterinary certificate with application to receive the relevant discount.
- You will receive a tag once you have completed the application process and we have received your payment.

### Important privacy information

Your information is required under the Act to register your dog(s). Failure to provide the requested information will result in your dog not being registered, which is an offence under the Act. Section 35 of the Act allows any person to apply in writing for the name and address of the owner of any specified dog. Whanganui Council is required to provide that information where it is satisfied of that person's identity and that the information is required for one of a limited number of purposes specified in section 35(5), such as returning a lost dog to its owner or seeking compensation for damage.

The personal information that you provide in this form will be held and protected by Whanganui Council in accordance with the Privacy Act 1993.
